2021 Insurance Renewal

Payment is due by August 13, 2021. The total cost of professional liability coverage, including taxes and expenses is \$475 for the 2021-2022 policy period.

RECO will be collecting more than 89,000 insurance payments over the summer. Pay by August 6, 2021 to ensure a worry-free payment before the busiest period of the renewal collection.
